### KSBHA suspends license of Parsons Chiropractor

The Kansas State Board of Healing Arts has suspended the license of Thomas C. Weaver, D.C., Parsons, for failure to comply with monitoring terms.

The Board originally entered into a consent agreement with Dr. Weaver in October 2006 following alleged violations such as inappropriate charging for x-rays, performing x-rays of no diagnostic value and failure to keep adequate patient records, amongst other things. As part of the consent order, the licensee agreed to abide by its terms, including further education, limitations and monitoring.

In March 2008, the Board issued an order suspending the licensee for failure to meet the terms of the consent order. However, the Board decided to stay the suspension, meaning it was put on hold, as long as Dr. Weaver met specifications outlined in a new agreement. Those specifications included providing monthly billing audit reports, monthly chart monitoring reports and further training.

The Board believes Dr. Weaver has not been in compliance with the 2008 consent order and has ordered that the stay on the suspension be lifted and the suspension for failure to comply with monitoring terms be imposed.

Dr. Weaver's license is suspended. In order for his license to become active and be authorized to practice chiropractic in Kansas, he will need to petition the Board to lift the suspension.
