**JOURNAL ENTRY GRANTING TIME EXTENSION**

The Kansas State Board of Healing Arts ("Board"), by its Acting Executive Director, Susan Gile, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about June 15, 2022, the Board entered into a Consent Order with Dr. Dennis R. Scharenberg, D.C. ("Dr. Scharenberg") imposing requirements thereon.
2. One of the requirements of the Consent Order is that Dr. Scharenberg complete, within six months of the date of execution of the Consent Order, at least 12 hours continuing education ("CE") for pediatric chiropractic treatment and care, as approved by the Board.
3. On or about July 19, 2022, the Board approved "Techniques: Thompson and Logan with Infant Exam," a 12-hour course presented by the International Chiropractic Pediatric Association ("ICPA") to comply with the Consent Order requirement for pediatric CE.
4. On or about September 18, 2022, Dr. Scharenberg notified the Board that the Board approved pediatric CE course on September 24-25, 2022, had been canceled and rescheduled for February 25-26, 2023, due to the instructor's family emergency.

5. Dr. Scharenberg requests the Board extend the time for him to complete the pediatric CE requirement to allow him to take the course as rescheduled on February 25-26, 2023.
6. **IT IS SO ORDERED** that Dr. Scharenberg's request to extend the time to complete the Consent Order pediatric CE is **GRANTED**. The Consent Order pediatric CE requirement shall be completed on or before **March 1, 2023**.


