ORDER TERMINATING CONFIDENTIAL

On December 9, 2022, this matter came before the Kansas State Board of Healing Arts (“Board”) a on a Motion to Modify Consent Order (“Motion to Modify”) filed on November 9, 2022, by Dr. Mark L. Allen (“Licensee” or “Dr. Allen”), through counsel, requesting termination **CONFIDENTIAL** contained in the Consent Order filed December 7, 2017. Licensee appeared in person and through counsel, Kelli Stevens of Forbes Law Group. Matthew Gaus, Deputy Litigation Counsel appeared on behalf of the Disciplinary Panel (“Panel”).

Under the authority granted to the Board by K.S.A. 65-2801 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, the Board hereby enters this Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving evidence, and being otherwise advised in the premises, the Board makes the following findings, conclusions and order:

FACTS

1. On December 7, 2017, Dr. Allen entered into a Consent Order with the Board in this matter to resolve the following allegations: (1) **CONFIDENTIAL** ; (2) Inability to practice the healing arts with reasonable skill and safety to patients by reason of **CONFIDENTIAL**; (3) Dr. Allen’s license was disciplined by Ohio; (4) Dr. Allen entered into a settlement agreement with the Ohio State Board of Pharmacy involving the withdrawal of Licensee’s application for a Terminal Distributor of Dangerous Drug License; and (5) Dr. Allen willfully and/or repeatedly violated the Kansas Healing Arts Act.

6. On November 22, 2022, the Panel filed a Response to Dr. Allen’s Motion to Modify (“Response”). The Response states that the Panel has no objection to Dr. Allen’s Motion provided Dr. Allen be required to continue with the monitoring provisions until December 28, 2022. Additionally, the Panel states the following:

a. Dr. Allen has been in compliance with the limitation of not practicing in a pain clinic wherein the sole purpose is to prescribe pain medications or solo practice. Dr. Allen is not asking to lift this limitation.


CONCLUSION


