PROPOSED DEFAULT ORDER

NOW, on this 18th day of October, 2001, comes on before the Kansas Board of Healing Arts (hereafter "Board") a Petition to Revoke, Suspend or Otherwise Limit the License of Scott E. Gilbert, M.D. (hereafter "Licensee"). Licensee does not appear either in person or through counsel. Stacy L. Cook, Litigation Counsel, appears for the Board.

The Board finds Licensee in default for his failure to attend and participate in the Conference Hearing on disciplinary petition which was scheduled for 10:15 a.m. on Saturday, August 18, 2001. The allegations of fact as stated in the July 27, 2001 Petition to Revoke, Suspend or Otherwise Limit License are adopted as the Board's findings of fact, conclusions of law and order.

WHEREFORE, the Board finds, concludes, and orders as follows:

- 1. On or about May 3, 2000, Licensee's license to practice medicine and surgery was revoked by the Oklahoma State Board of Medical Licensure and Supervision ("Oklahoma Board").
- 2. As provided by K.S.A. 65-2836(j), Licensee's license may be revoked, suspended or otherwise limited due to the fact that Licensee has had a license revoked by the proper licensing authority of another state.

- 3. The grounds for the Oklahoma Board's revocation of Licensee' license included gross negligence, (Confidential) , inability to practice medicine with reasonable skill and safety to patients, using non FDA-approved surgical equipment, prescribing controlled substances without medical need, aiding and abetting the practice of medicine by individuals not duly authorized under the laws of the state, false or fictitious prescription of drugs, (Confidential) (Confidential)
- 4. The acts or conduct by Licensee which were grounds for the Oklahoma Board's action are similar to acts or conduct which would also be grounds for disciplinary action under the Healing Arts Act. K.S.A. 65-2801 *et seq*; K.S.A. 65-2836(b), K.S.A. 65-2837(a)(1).
- 5. On June 14, 1999, Doctors Hospital suspended Licensee's privileges. Licensee failed to report to the Board that his hospital privileges were suspended.

7. The Board may revoke, suspend or otherwise limit Licensee's license for committing fraud or misrepresentation in securing a renewal license. K.S.A. 65-2836(a).

IT IS THEREFORE ORDERED that the license of Scott E. Gilbert, M.D. be revoked.

PLEASE TAKE NOTICE that this is a Proposed Default Order. A party against whom a Proposed Default Order is issued may file a Motion to Vacate the order. A Motion to Vacate the Proposed Default Order must be filed with the Executive Director, 235 S. Topeka Boulevard, Topeka, Kansas 66603. Any such motion is not timely unless filed within 7 days following service of the Proposed Default Order. If no timely Motion to Vacate the Proposed Default Order is received, the proposed order becomes the Board's Final Order without further proceedings or notice.

Respondent has not filed a motion requesting that the Proposed Default Order be vacated and, therefore, by operation of law, the Proposed Default Order became effective September 6, 2001, and Respondent's license to practice medicine and surgery in the state of Kansas is revoked as of that date.
