**AGREED JOURNAL ENTRY AND FINAL ORDER**

This matter comes before the Kansas State Board of Healing Arts (Board) upon application of Applicant Ehab Farouk Abdalah, M.D. (Dr. Abdalah and/or Applicant) for issuance of a Kansas medical license by endorsement based upon having been issued an unrestricted license to engage in the practice of medicine and surgery in the State of New York on February 23, 2006. The Board appears by and through its Litigation Counsel, Kelli Stevens. Applicant appears by and through his counsel, Steve A. Schwarm, Polsinelli Shalton Welte Suelthaus PC. There are no other appearances and none are necessary.

The Board notes that Kansas Healing Arts Act, specifically, K.S.A. 65-2833, provides that the Board without examination, may issue a medical license to a person who has been in the active practice of the branch of the healing arts in another state upon certification of the proper licensing authority of that other state certifying that the Applicant is duly licensed, that the Applicant's license has never been limited, suspended or revoked, that the Licensee has never been censured or had other disciplinary action taken and that, so far as the records of such other authority or concern, the Applicant is entitled to endorsement.

The Board finds that the State of New York has issued an unrestricted medical license to Applicant having issued same on February 23, 2006. Additionally, the Board notes that the Board has received verification of such New York license directly from the issuing licensing authority of the State of New York. Further, the Board finds that Applicant meets all other requirements pertaining to endorsement licenses under K.S.A. 65-2833.

WHEREAS, the Board finds that Applicant has been issued an unrestricted New York medical license and that such complies with all provisions of K.S.A. 65-2833, that this conclusion of law of meeting the requirements of K.S.A. 65-2833 is based upon evidence of the verified license from the State of New York. It is, therefore, the decision of the Board that, based upon the evidence before it and for good cause shown, Applicant should be issued an unrestricted license to engage in the practice of medicine and surgery in the State of Kansas under the authority of the Kansas Healing Arts Act as administered by the Kansas Board of Healing Arts.

WHEREFORE, Applicant, Ehab Farouk Abdalah, M.D., is hereby granted a license to engage in the practice of medicine and surgery in the State of Kansas by the Kansas Board of Healing Arts based upon the findings of fact and conclusions of law otherwise detailed above. Such being effective on the date listed below.




