**ORDER TERMINATING STIPULATION AND  
DISSOLVING ENFORCEMENT ORDER**

NOW, on this 13th day of April, 1991, comes on for summary proceedings the request of Francis Abraham, D.P.M. (hereafter "Licensee") for termination of Stipulation.

Licensee appears in person pro se. Litigation Counsel, Steve A. Schwarm, appears on behalf of the Board. There are no other appearances.

After reviewing the file and being otherwise duly advised in the premises, the Kansas State Board of Healing Arts (hereafter "Board") makes the following findings of fact, conclusions of law and order:

1. On February 11, 1989, Licensee entered into a Stipulation with the Board which required Licensee to limit his surgical procedures to toenails, papillomas, superficial skin lesions, ganglions and epidermoid cysts in the absence of the personal attendance and supervision of a qualified individual approved by the Board. Licensee also agreed to successfully complete a minimum of a one-week residency program devoted solely to surgical techniques and the preoperative criteria for surgery. Licensee

also agreed to provide to the Board, at least weekly, a list of individuals upon who Licensee performed any surgical procedures.

2. On February 11, 1989, the Board issued an Enforcement Order based upon the conditions as stated in the aforementioned Stipulation.

3. Licensee has submitted evidence of successful completion of a one-week mini-residency program.

4. Licensee has submitted to the Board lists of surgical procedures performed.

5. Licensee has requested that the aforementioned Stipulation be terminated and the Enforcement Order based thereon be dissolved.

6. The Stipulation between the Board and Licensee dated February 11, 1989, should be terminated and the Enforcement Order issued by the Board should be dissolved.

7. With the termination of the Stipulation and dissolution of the Enforcement Order, Licensee should be discharged from any restrictions thereby imposed on his license to practice podiatry in the State of Kansas.

IT IS THEREFORE ORDERED BY THE BOARD that the Stipulation dated February 11, 1989, between the Licensee and the Board be terminated in its entirety and shall hereafter have no further force or effect; that the Enforcement Order based upon the Stipulation between Licensee and the Board dated February 11, 1989, be hereby dissolved; and that the license of Licensee to practice podiatry in the State of Kansas shall hereafter be without any restrictions or limitations.

IT IS SO ORDERED.


