**COMES NOW** the Kansas State Board of Healing Arts ("Board"), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

- 1. On November 16<sup>th</sup>, 2018 the Board issued a Summary Order imposing the requirements therein.
- 2. The Summary Order, upon effectiveness as a Final Order, would indefinitely suspend Licensee's license to practice podiatry in Kansas until Licensee obtained and maintained a policy of professional liability insurance provided proof of payment of premium surcharges required under K.S.A. 40-3404.
- 3. Licensee complied with the above stated requirement before the Summary Order became effective as a Final Order. Therefore, Licensee's license was not suspended at any time. Upon the initial filing of the Summary Order on November 16<sup>th</sup>, 2018, Licensee's licensee status was changed from exempt to active.
- 4. On March 8, 2018 the Board received evidence of compliance with all other requirements of the Summary Order.
- 5. Licensee has no further obligation for compliance with the Summary Order.
