3. The Board finds that no cause exists to deny Applicant a full, unlimited license to practice medicine and surgery and therefore, Applicant's Application should be approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Applicant's Application for Endorsement is hereby approved.


