
1. On or about January 22, 2009, Applicant submitted an application to practice medicine and surgery in Kansas. The application was deemed complete and filed on July 17, 2009.
2. Through no fault of her own, Applicant has been unable to supply the board with medical school transcripts and she requests licensure by endorsement.
3. Applicant has had a license in good standing in Missouri since 1981 without disciplinary actions.
4. Applicant is granted a license to practice medicine and surgery in Kansas.

PLEASE TAKE FURTHER NOTICE that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq.

Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon the Board's Executive Director at 235 SW. Topeka Blvd., Topeka, KS 66603.
