FINAL ORDER GRANTING LICENSURE

NOW on this 12th day of April 2013, comes before the Kansas State Board of Healing Arts (“Board”) the application of Samuel K. Akidiva, M.D. (“Applicant”) for a license to practice medicine and surgery in the State of Kansas. Applicant appears in person and *pro se*. Reese H. Hays, Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. On or about January 18, 2013, Samuel K. Akidiva, M.D. (“Applicant”) submitted an application to the Board for a license to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on March 28, 2013.
2. In December of 2004, Applicant graduated from Moi University in Kenya with a Bachelor of Medicine and Bachelor of Surgery.

3. Applicant completed a one-year internship at Moi Teaching and Referral Hospital in Eldoret, Kenya in December of 2005. In July of 2010, Applicant began his residency at the KU School of Medicine in Wichita, Kansas, and is currently in his third year. He intends to finish his residency in June 2013. Upon completion, Applicant intends to practice internal medicine at the KU School of Medicine in Wichita, starting in July 2013.

4. Applicant received his Education Commission for Foreign Medical Graduates (ECFMG) certification in January 2009.

5. Applicant has passed all three steps of the USMLE. He passed Step 1 of the USMLE on September 14, 2001, and passed Step 3 on March 20, 2012.


6. K.A.R. 100-7-1(b)(1) requires that applicants complete step 2 and step 3 of the USMLE within 10 years after passing step 1 of the examination.

7. Applicant passed all three steps within 10 years, 6 months and 6 days.

8. The Board finds that Applicant has demonstrated substantial compliance with K.A.R. 100-7-1(b)(1) to be granted a license to practice medicine and surgery in the State of Kansas.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby granted a license by endorsement to practice as medicine and surgery in the State of Kansas.


