**FINAL ORDER EXTENDING TEMPORARY LICENSE**

**NOW**, on this 11<sup>th</sup> day of December comes on for conference hearing before the Kansas State Board of Healing Arts ("Board") the request of Muhammad Q. Akram, P.A. ("Petitioner") to further extend his Temporary License Number 0425332 to practice as a physician assistant. Charlene K. Abbott, Licensing Administrator, presented information to the Board. Petitioner appeared in person *pro se*. There were no other appearances.

After hearing the information provided by Charlene K. Abbott and Petitioner and being otherwise duly advised in the premises, the Board makes the following findings and orders:

1. Petitioner was issued a temporary license to practice as a Physician Assistant on September 25, 2003 which was effective for one year through September 24, 2004, as specified by K.S.A. 65-28a07(b).
2. By Final Order filed October 27, 2004, the Board extended Petitioner's temporary license until December 11, 2004.
3. On November 30, 2004, Petitioner filed a request for further extension of his temporary license.
4. K.S.A. 65-28a07(b) allows the Board to extend a temporary license, upon a majority vote of the members of the Board, for a period not to exceed one year.


5. The Board finds that sufficient cause exists to further extend Petitioner's temporary license until April 23, 2005.

**IT IS THEREFORE ORDERED** that Temporary License Number 0425332 be further extended until April 23, 2005 and be considered to have been continuously effective from and since its original date of issuance on September 25, 2003.


