ORDER TERMINATING STIPULATION

NOW ON THIS 14th day of October, 2000, comes on for Conference Hearing before the Board of Healing Arts ("Board") the request of Alan Albarracin, M.D. ("Licensee") that the Stipulation filed on December 9, 1988 be terminated. Kelli Benintendi, Associate Counsel, appears for the Board. Dr. Albarracin appears pro se.

After examining the files, hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

- 1. A Stipulation was entered into between Licensee and the Board on December 9, 1988 when Licensee voluntarily agreed to limitations being placed on his license to practice medicine and surgery. Said Stipulation was made the order of the Board in the subsequent Enforcement Order filed January 20, 1989.
- 2. Paragraph 2 of said Stipulation provided that it remain in full force and effect until modified, amended or rescinded by the parties.
 - 3. On September 26, 2000 Licensee requested removal of the stipulation from his license.
- 4. Notice of Conference Hearing setting this matter for hearing at 11:45 a.m. on October 14, 2000 was filed herein on September 29, 2000 and served on Licensee.
- 5. After hearing statements of the parties, the Board is satisfied that Licensee has been in compliance with the conditions and limitations placed upon his license.
 - 6. The Stipulation filed on December 9, 1988 should be terminated.

NOW THEREFORE, it is ordered that the findings above made be and the same are hereby made the order of the Board; that the Stipulation is hereby terminated; that any and all restrictions

and limitations placed on Licensee's license to practice medicine and surgery in the State of Kansas are terminated and shall be of no further force or effect.
