

**FINAL ORDER**

NOW ON THIS Thirty-first Day of January 2004, comes before the Board a request by Steven E. Albert, D.O. to modify the limitation on his license imposed by the December 13, 2000 order. Dr. Albert appears in person and through L. J. Leatherman, Attorney at Law. Stacy L. Cook, Litigation Counsel, appears for the Board.

After hearing the statements of counsel, the Board determines that the limitation on his license should be terminated upon the issuance of a final order approving a peer to act as a mentor for Dr. Albert. Such mentor shall not be required to monitor all aspects of Dr. Albert's practice, but shall be available for regular and periodic consultation. This mentor relationship is ongoing until further order of the Board, but is not deemed a limitation upon Dr. Albert's license. Board President John Gravino, D.O. is appointed to issue a final order approving a mentor.


