SUMMARY ORDER

NOW, on this 12th day of March, 1993, comes on for consideration before Rex A. Wright, President, Kansas State Board of Healing Arts (hereafter "Board") sitting as Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 77-538, the request submitted by Steven B. Gollub, M.D. for the extension of a post-graduate training permit retroactively to Anthony A. Albracht, M.D. (hereafter "Applicant") for the period June 30, 1992 through June 30, 1993. Applicant did not appear.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. On or about April 24, 1990, an Application was filed in the Board office requesting that Applicant receive a post-graduate training permit to engage in post-graduate training from July 1, 1990 through June 30, 1992.

2. On May 30, 1990, Applicant received post-graduate training program temporary permit number 94-03146 to engage in a post-graduate training program beginning July 1, 1990 in the Department of Cardiovascular Diseases at the University of Kansas Medical Center at Kansas City, Kansas through June 30, 1992.

SUMMARY ORDER

3. Applicant has been solely engaged in the training program through KUMC continuously from and since July 1, 1990. Applicant has not participated in any clinical activity outside the training program.

4. Applicant has participated in the training program under the belief that all necessary requirements for obtaining the post-graduate training program temporary permit had been met and said permit had been issued for the period ending June 30, 1993.

5. That upon realizing that said temporary permit had been issued for the period of time July 1, 1990 through June 30, 1992, Applicant made a written request for retroactive extension of his postgraduate training permit.

6. The Board has subsequently received notification from KUMC that Applicant's temporary permit should have been requested to expire on June 30, 1993 and not June 30, 1992 as previously requested by the school.

7. That at all times Applicant has participated in post-graduate training at KUMC from and since July 1, 1990, Applicant had met all the requirements for the issuance of a temporary post-graduate training permit for post-graduate training pursuant to K.S.A. 65-2811(a)(1) but that solely due to inadvertence, mistake or misunderstanding in providing the date of termination of the training program, said temporary training permit was cancelled as of June 30, 1992.

IT IS THEREFORE ORDERED as follows:

SUMMARY ORDER

A. That the findings here and above made be and the same are made the Order of the Board.

B. That temporary permit number 94-03146 for the purposes of engaging in post-graduate training at the University of Kansas Medical Center at Kansas City, Kansas should be forthwith extended to be effectively from and since June 30, 1992 through June 30, 1993.


C. Applicant is entitled to an administrative review of this Order if a written request is received in the Board office within fifteen (15) days of the service of this Order upon Applicant.

IT IS SO ORDERED.


