ORDER MODIFYING STIPULATION AND AGREEMENT AND ENFORCEMENT ORDER

COMES NOW, the Kansas State Board of Healing Arts (hereinafter "Board") sitting in Conference Proceeding to consider the Petition For Removal of Certain Restrictions Upon Licensure, offered by Dr. Jerold D. Albright, M.D., through his counsel of record, Mr. Larry Shoaf, Esq., of McDonald, Tinker, Skaer, Quinn & Herrington, P.A. Said Petition requests modification of the Stipulation and Agreement and Enforcement Order pertaining to the abovementioned matter filed April 19, 1993 in the offices of the Board. Dr. Albright appears personally and with counsel, Mr. Shoaf. The Board is represented by Mr. Kevin K. LaChance, Board Associate Counsel.

After consideration of the petition, exhibits offered in support of the petition, the original Stipulation and Agreement and Enforcement Order, the monitoring reports, and suggestions of counsel, the Board finds as follows:

1. That Dr. Albright has to date satisfactorily complied with the requirements of the Stipulation and Agreement and Enforcement Order.
2. That Paragraph 6(c)(i) of the Stipulation and Agreement and Enforcement Order should be modified, to the extent that the biweekly monitoring and report requirement is hereby eliminated. It is replaced with the requirement that a monitoring report be provided to the legal staff of the Board on or about March 1, 1994, and a second report provided prior to the April 1994 Board Meeting, which is scheduled for April 16, 1994.

3. The remaining portions of the Stipulation and Agreement and Enforcement Order remain in full effect.


