ORDER RETROACTIVELY EXTENDING POSTGRADUATE PERMIT

NOW, on this 11th day of December, 2004, comes on before the Kansas State Board of Healing Arts ("Board") for Conference Hearing the request made on behalf of Aakash R. Amin, M.D. ("Applicant") for retroactive extension of Postgraduate Permit Number 94-05902. Charlene K. Abbott, Licensing Administrator, presented information to the Board. Applicant appeared in person *pro se*. There were no other appearances.

After hearing statements from Licensing Administrator and Applicant, reviewing the request and being duly advised in the premises, the Board finds and orders as follows:

- 1. Applicant was originally issued Postgraduate Permit Number 94-05902 under the provisions of K.S.A. 65-2811(b) and (c) to engage in an internal medicine postgraduate training program at the University of Kansas Medical Center for the period July 1, 2003 through June 30, 2004.
- 2. Subsequent to the issuance of the postgraduate permit, Applicant was accepted into a three-year Categorical program.
- 3. On September 8, 2004, Applicant filed a request that his postgraduate permit be extended through June 30, 2006, to enable completion of the categorical program.
- 4. On September 9, 2004, Applicant's postgraduate permit was extended through June 30, 2006.

5. On September 20, 2004, the Board received a request on behalf of Applicant requesting

that this postgraduate permit be made retroactively effective from July 1, 2004 through September

8, 2004.

6. Solely due to inadvertence and mistake and not as a result of any intentional misconduct

on the part of Applicant, Applicant was without a postgraduate permit for the period July 1, 2004

to September 9, 2004.

7. That Postgraduate Permit Number 94-05902 should be modified, extended and made

retroactively effective from July 1, 2004 through June 30, 2006.

IT IS THEREFORE ORDERED that Postgraduate Permit Number 94-05902 originally

effective for the period July 1, 2003 through June 30, 2004 is retroactively extended to be

continuously effective for the period July 1, 2003 through June 30, 2006 and that the records of the

Board be modified to reflect such retroactive extension.

IT IS SO ORDERED.
