ORDER OF RETROACTIVE MODIFICATION TO LICENSE STATUS

NOW, on this 30th day of March, 1992, comes on for consideration before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts, sitting as Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 1991 Supp 77-538, the request of Jafar Amini, M.D., (hereafter "Licensee") for retroactive modification of license status. Licensee did not appear.


After reviewing the request and being otherwise duly advised in the premises, the following findings are made:

1. Licensee was originally licensed to practice medicine and surgery in the state of Kansas on June 19, 1982.
2. On June 11, 1991, Licensee applied for renewal of his license for the period ending June 30, 1992.
3. On June 11, 1991, as part of his application for renewal of his license for the period July 1, 1991 through June 30, 1992, Licensee filed with the Board a Status Change Form on which he requested that his active license be changed to federal active

status and such request was processed by Board staff and the license status changed from active to federal active status effective June 11, 1991.

4. That Licensee's license remained on federal active status from and since June 11, 1991 until February 20, 1992 when Licensee requested that the license status be changed to active.

5. That Licensee obtained professional liability insurance in compliance with Kansas law effective October 2, 1991 and was eligible to have his license placed on active status at that time but, due to misunderstanding or inadvertence, failed to do so.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

A. That the findings here and above made be and the same are made the order of the Board.

B. The status of the license of the Licensee, Jafar Amini, M.D., to practice medicine and surgery in the state of Kansas should be retroactively modified to reflect that Licensee held an active license from October 2, 1991 and will have active status continuously from October 2, 1991 until June 30, 1992 unless Licensee hereafter applies for a further status modification.

C. Licensee is entitled to an administrative review of this Order of Retroactive Modification to License Status if a written request is received in the Board office within 15 days of the date of service of this Order upon Licensee.
