**SUMMARY ORDER**

**NOW**, on this 21st day of October, 1999, this matter comes before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board") in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and orders are made for and on behalf of the Board:

- 1) On or about July 15, 1999, John Roy Anderson (hereafter "Applicant") filed an Application For Registration As A Respiratory Therapist with the Board.
- 2) In response to item number 20 of the application, Applicant has not submitted an official transcript and notarized copy of diploma from an educational program recognized by the Board.
- 3) Pursuant to K.S.A. 65-5506(1), an applicant shall present evidence satisfactory to the board of having successfully completed the academic requirements of an educational program in respiratory therapy recognized by the board.

4) Applicant has not completed the application as required by K.S.A. 65-5506 by submitting an official transcript and notarized copy of diploma from an educational program recognized by the Board.

**IT IS THEREFORE ORDERED AND DECREED** for and on behalf of the Board as follows:

a) That, pursuant to K.S.A. 65-5506, Applicant has not successfully completed the application and met the requirements provided for registration as a respiratory therapist in the State of Kansas.


b) Applicant's Application For Registration As A Respiratory Therapist received by the Board on July 15, 1999 be **DENIED**.

c) This is a Summary Order and either party is entitled to a review if a written request is received in the Board office within 15 days of service of the Order upon the parties. If no request is received, this Order will become immediately effective.


