ORDER OF RECONSIDERATION AND STAY

NOW, on this 17th day of August, 1991, this matter comes on for further consideration before the Kansas State Board of Healing Arts (hereafter "Board") the Motion for Reconsideration of Final Order issued by the Board on April 13, 1991 and served May 14, 1991 filed by Hampton W. 
