**AGREED ORDER FOLLOWING EMERGENCY PROCEEDINGS**

**NOW**, on this 30<sup>th</sup> day of April, the above-titled matter comes on for decision by the Presiding Officer, Lawrence T. Buening, Jr. on Petitioner’s Motion for Order Temporarily Suspending and/or Limiting License and For Emergency Proceedings on Petition to Revoke, Suspend, or Otherwise Limit License. A hearing on said motion was conducted on April 30, 1999. Petitioner appears by and through its Litigation Counsel, Stacy L. Cook. Mohammad Z. Anwar, M.D. (“Licensee”) appears in person and by counsel Gary Fuller.

The parties stated to the Presiding Officer that Licensee agrees to an Order temporarily suspending his license until such time as a formal hearing can be concluded. Further, the parties have requested additional time before the formal hearing process is initiated. K.S.A. 77-536(e) provides that after issuance of an Order pursuant to the emergency proceedings provision, the state agency shall proceed as quickly as feasible to complete any proceedings that would be required if the matter did not justify the use of emergency proceedings. The parties request that the formal hearing process not be initiated until one or both of the parties files a written request for the hearing process to be initiated.


The parties also request, (confidential) \_\_\_\_\_, that a Protective Order be entered prohibiting disclosure of exhibits (confidential)


