FINAL ORDER GRANTING WITHDRAWAL OF APPLICATION FOR LICENSURE AS AN ATHLETIC TRAINER

NOW on this 13th day of April, 2012, comes before the Kansas State Board of Healing Arts ("Board") the application of David W. Appleman ("Applicant") for a license to practice as an athletic trainer in the State of Kansas. Applicant appears in person through counsel, Matthew J. Condon. Reese Hays, Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by K.S.A. 65-6901 et seq. and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 et seq., the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, the evidence presented, and hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

- 1. On or about June 24, 2011, David Appleman ("Applicant") submitted an application to the Board for licensure as an athletic trainer in the State of Kansas.
2. On or about November 18, 2011, Applicant was granted licensure as an athletic trainer in the State of Missouri. Subsequently, Applicant requested a Kansas license by endorsement pursuant to K.S.A. 65-6906.

3. Applicant's application was deemed complete and filed with the Board on January 4, 2012.

4. Applicant requests the Board grant withdrawal of his application for licensure as an athletic trainer by endorsement.


5. The Board grants such withdrawal of Applicant's application.


