## FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW on this 27th day of April, 1996, this matter comes for conference proceedings before the Board of Healing Arts (hereafter "Board") at the request of Nayla Qamar Asar, M.D. (hereafter "Applicant") for permission to sit for the USMLE Step 3 Examination to be given in May, 1996.

Charlene K. Abbott, Licensing Adminstrator, presents information to the Board. Applicant appears in person *pro se*. There are no other appearances.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

- 1. Applicant has failed the USMLE Step 3 examination on three attempts.
- 2. By letter dated March 4, 1996, Applicant requested the Board permit her application for processing for the May 1996 USMLE examination.
- 3. Notice of Conference Hearing setting this matter for hearing at 10:30 a.m. on April 27, 1996 was filed herein on April 11, 1996 and served on Applicant that same date.
- 4. Board Policy Statement No. 93-03 states that no individual who has failed any of the examinations approved for licensure and required under K.S.A. 65-2873(a)(1) or K.S.A. 65-2873(a)(3) on three or more occasions shall be eligible for licensure without having completed additional educational requirements established by the Board.

5. Applicant is currently in her fourth year of residency in child psychiatry at the

University of Kansas Medical Center.

6. Applicant has prepared a self-educational plan to prepare her for the USMLE exam.

7. The Board finds that sufficient cause exists to allow Applicant to sit for the USMLE

exam to be given in May, 1996.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

A. That Applicant is hereby granted permission to sit for the USMLE examination to

be given in May, 1996.

B. That this Order does not constitute approval of Applicant's Application for Licensure.

Applicant's Application will not be considered by the Board until she passes the required

examinations and can provide proof as such, submits all documentation required by the Application,

and until said Application is complete.

C. That this is a Final Order and is effective upon service upon the parties. Any party

may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a

Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
