FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT

NOW on this 14th day of June 2013, comes before the Kansas State Board of Healing Arts ("Board") the application of Kim Baker ("Applicant") for a license to practice medicine and surgery in the State of Kansas. Applicant was available by telephone for appearance, but did not appear. Seth Brackman, Associate Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, et seq. and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, et seq., the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

- 1. On or about February 25, 2013, Applicant submitted an application to the Board for a license to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on April 2, 2013.
2. Applicant graduated from medical school in 1989, from the University of Alberta, in Alberta, Canada.
3. Applicant passed all 3 steps of the USMLE within 10 years.

4. Applicant has only completed one year of ACGME accredited postgraduate training.

5. In June of 1994, Applicant successfully completed a four-year residency in diagnostic radiology at the University of Calgary in Alberta, Canada. The residency was accredited by the RCPSC. In 1996, Applicant completed a two-year fellowship in neuroradiology at the Washington University School of Medicine in Saint Louis, Missouri. The first year of the fellowship was ACGME accredited.


6. In 2002, Applicant was granted full licensure to practice medicine and surgery in Colorado. In 2009, Applicant was granted full licensure to practice medicine and surgery in Nebraska. Both of Applicant's licenses are currently active with no disciplinary action.

7. Since 2002, Applicant has practiced as a radiologist at Radiology Imaging Associates, PC in Englewood, Colorado.

8. The Board finds that the Applicant has demonstrated satisfactory fulfillment of the active practice requirement of K.S.A. 65-2833 to be granted a license by endorsement to practice medicine and surgery in the State of Kansas.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby granted a license by endorsement to practice medicine and surgery in the State of Kansas.


