**FINAL ORDER AND JOURNAL ENTRY OF SATISFACTION  
OF REQUIREMENTS OF FINAL ORDER**

NOW ON THIS 20<sup>th</sup> day of September, 2010, the above-entitled matter comes on before Kathleen Selzler Lippert, Executive Director of the Kansas State Board of Healing Arts (“Board”). After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On August 23, 2010, the Executive Director issued a Summary Order regarding the license of Katrina D Barr, R.T. (“Licensee”) to practice as a respiratory therapist in the state of Kansas. The Summary Order contained a provision assessing a \$100 civil fine against Licensee for failure to have met the continuing education requirement at the time of renewal, due and payable within thirty (30) days of the effective date of the Summary Order.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would be come effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. No hearing has been requested by any party; therefore the Summary Order became effective as a Final Order on September 13, 2010.

4. On September 10, 2010, Licensee remitted \$100.00 to the Board for satisfaction of the \$100 civil fine.

5. Licensee has satisfied all requirements of the Final Order and has no further obligation for compliance.


**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from the requirements of the Final Order.



**ORDER NUNC PRO TUNC**



**SUMMARY ORDER**

**NOW ON THIS** *23<sup>rd</sup>* day of August, 2010, this matter comes before Kathleen Selzler Lippert, Executive Director, Kansas State Board of Healing Arts (“Board”), in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

1. Jerome C Duran, RT (“Licensee”) was originally issued license number 16-03414 to practice as a respiratory therapist in the State of Kansas on November 9, 2006.
2. On or about March 30, 2010, Licensee submitted an application for renewal of their license.
3. Pursuant to K.S.A. 65-5512 and K.A.R. 100-55-7 each Licensee desiring to renew a respiratory therapy license must have completed at least 12 credits of continuing education and to provide proof of completion to the Board upon request
4. As part of the renewal process, Licensee certified that the rules regarding continuing education had been read, that compliance had been achieved, and that documentation of the continuing education would be maintained for a three-year period and produced to the Board upon request.
5. Licensee was randomly selected to provide verification of compliance with the continuing education requirements and on May 10, 2010, a letter was mailed to Licensee

requesting that Licensee provide no later than June 18, 2010, the records relied upon when Licensee certified achievement of the required continuing education.

6. A second letter requesting proof of continuing education by July 9, 2010 was sent to licensee on June 23, 2010 by certified mail through the United States Postal Service.

7. Licensee notified the Board by phone on July 15, 2010 that she was only able to find 5 hours after moving.

8. Licensee was given an extension to find her hours until July 30, 2010.

9. Licensee submitted proof of 5 hours of the required 12 hours, so license is short a total of 7 hours of continuing education.

10. Licensee submitted 5 hours of continuing education on August 3, 2010. Licensee also submitted an additional 14 hours double the hours she was short, on August 3, 2010.

11. Licensee failed to provide documented evidence of continuing education by the due date.

12. By failing to provide documented evidence of her continuing education, Licensee has violated K.S.A. 65-5510(a)(4), violating any lawful order or rule and regulation of the board, specifically K.A.R. 100-55-5(h) failing to furnish to the Board, or to its investigators or representatives, any information legally requested by the Board.

13. In addition to any other penalty prescribed under the Respiratory Therapy Practice Act, K.S.A. 65-5510 authorizes the Board to assess an administrative fine in an amount not exceeding \$5,000 for the first violation of the Respiratory Therapy Practice Act.


**IT IS, THEREFORE, ORDERED** Licensee be assessed a civil fine in the amount of \$100, payable within thirty days of the effective date of this order, for failure to have met the continuing education requirement at the time of renewal.

**IT IS FURTHER ORDERED** that licensee's license shall be suspended for failure to pay the fine in compliance with this order, or fails to file a notice for a hearing.

**PLEASE TAKE NOTICE** that this is a summary order. A party to whom a summary order is issued may file a written request for a hearing within 15 days following service of the summary order. If a hearing is not requested, the summary order shall become effective as a final order of the Board upon expiration of the time for requesting a hearing. A request for a hearing must be addressed to Kathleen Selzler Lippert, Executive Director, 235 South Topeka Boulevard, Topeka, Kansas 66603.
