**SUMMARY ORDER**

**NOW**, on this 17<sup>th</sup> day of October, 1998, this matter comes before the Kansas State Board of Healing Arts (hereafter "Board") regarding the license renewal application of Bruce Barter, M.D. (hereafter "Licensee"). Charlene K. Abbott, Licensing Administrator, presents information to the Board. Licensee does not appear. After reviewing the information, the Board finds as follows:


- 1) Licensee's renewal application was received in the Board office on August 5, 1998 and was deemed to be complete. No proof of insurance was required as Licensee is applying for exempt status.
- 2) Licensee's license was summarily canceled effective August 1, 1998 for failure to renew.
- 3) Licensee requests the Board accept a late renewal of exempt license in the amount of \$120 and waive the reinstatement fee of \$250.

- 4) The Board took this matter under consideration at the October 17, 1998 Board Meeting and it is their opinion that in order for Licensee to be properly licensed in Kansas, Licensee be required to pay the reinstatement fee of \$250 by December 10, 1998, and the license renewal form that Licensee completed and was received in this office on August 5, 1998 will serve as the reinstatement form. Payment of the reinstatement fee after December 10, 1998 will require an Application for Reinstatement to be completed by Licensee as the Renewal Application for Medicine and Surgery from July 1, 1998 to June 30, 1999 will no longer be considered an appropriate form for reinstatement.

**IT IS THEREFORE ORDERED** that after due consideration, the reinstatement fee will not be waived.

This is a Summary Order. A party may request a hearing of a Summary Order within 15 days following service of the Summary Order. If a hearing is not requested, the Summary Order becomes effective upon the expiration of the time for requesting a hearing.
