**FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT**

**NOW** on this 19<sup>th</sup> day of October, 2012, comes before the Kansas State Board of Healing Arts (“Board”) the application of Rajat Barua, M.D. (“Applicant”) for licensure by endorsement to practice medicine and surgery in the State of Kansas. Applicant appears in person and *pro se*. Reese Hays, Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. On or about July 11, 2012, Applicant submitted an application for licensure by endorsement to practice medicine and surgery in the State of Kansas. Such application was deemed complete and filed with the Board on or about September 24, 2012.

2. In December of 1996, Applicant graduated from Nalanda Medical College in Patna, Bihar, India. However, Applicant has been unable to obtain official verification of his medical school education directly from the College to submit to the Board with his application.

3. Applicant provided unofficial copies of his medical school transcripts to the Board.

4. Applicant passed all 3 steps of the USMLE between 1994 and 1998 as required by K.S.A. 65-2873.

5. Applicant completed one (1) year of Accreditation Council for Graduate Medical Education (ACGME) accredited postgraduate training program with the James J. Peters Veterans Affairs Medical Center in Bronx, New York on June 30, 2004. Applicant then completed two years of ACGME accredited residency program at the same facility on June 30, 2006. Applicant participated in an ACGME accredited fellowship at the University of California in San Francisco in Cardiology from July 1, 2006 to June 30, 2007. Applicant then participated in an ACGME accredited fellowship at the University of California in San Francisco in Internal Medicine/Cardiovascular Disease from July 1, 2007 to June 30, 2009. Finally, Applicant also participated in an ACGME accredited fellowship at Tufts Medical Center in Boston, Massachusetts in Cardiology/Interventional Cardiology from July 1, 2009 to June 30, 2010.

6. Applicant is currently licensed to practice medicine in the State of California, having been licensed in 2005. There are no reported disciplinary actions against Applicant's California license.

7. Applicant is also currently licensed to practice medicine in the State of Massachusetts, having been licensed in 2009. There are no reported disciplinary actions against Applicant's Massachusetts license.

8. Applicant received his Education Commission for Foreign Medical Graduates (ECFMG) certification in September 1997.

9. Applicant is board-certified in Internal Medicine, Cardiovascular Disease and Interventional Cardiology.


10. Applicant has been a staff Interventional Cardiologist at the Kansas City Veterans Administration Medical Center in Missouri since approximately December of 2010.

11. The Board finds that Applicant has provided satisfactory proof of his medical school education by virtue of his licensure in California and Massachusetts.

12. The Board finds that Applicant has demonstrated satisfactory fulfillment of K.S.A. 65-2833 to be granted a license by endorsement to practice medicine and surgery in the State of Kansas.

**IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS** that Applicant is hereby granted a license by endorsement to practice medicine and surgery in the State of Kansas.


