FINAL ORDER TERMINATING MONITORING

NOW on this 14th day of October, 2015, comes before the Kansas State Board of Healing Arts (“Board”) the request filed by Sara Baskerville-Crome, D.C. (“Licensee”) to terminate the monitoring requirement contained in her Consent Order. Licensee appears in person, and *pro se*. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving exhibits into evidence, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of chiropractic in the State of Kansas, having been issued License No. 01-05005 on approximately December 10, 2005.
2. On or about February 24, 2014, Licensee entered into a Consent Order with the Board to resolve, in part, concerns of impairment.
3. The Consent Order required Licensee to attend and successfully complete the in-person Medical Record Keeping Seminar offered by the Center for Personalized Education (“CPEP”).
4. Licensee completed the Medical Record Keeping Seminar on December 5, 2014.

5. The Consent Order also required Licensee to be subject to practice monitoring in the form of having a percentage of her patient records reviewed by another Kansas-licensed chiropractor for at least one year.

6. Licensee requested and was granted termination of the practice monitoring requirement on June 30, 2016.

7. The Consent Order also required Licensee to follow all the terms of her [REDACTED] monitoring [REDACTED] entered on September 3, 2013, for at least (3) three years.


8. On July 18, 2016, Licensee submitted a request to terminate the [REDACTED] monitoring requirement in the Consent Order.

9. On September 9, 2016, Associate Litigation Counsel filed a Response which detailed Licensee's compliance with the [REDACTED] monitoring provisions of the Consent Order.

10. The Board finds and concludes that Licensee has satisfactorily complied with the [REDACTED] monitoring provision of the Consent Order and termination is warranted under the circumstances.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Licensee's request to terminate the [REDACTED] monitoring requirement in the Consent Order is hereby **GRANTED** and Licensee shall have no further obligation for compliance.

Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
