NOW ON THIS 16 day of May, 2011, the above-entitled matter comes on before Kathleen Selzler Lippert, Executive Director of the Kansas State Board of Healing Arts ("Board"). After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On May 3, 2011, the Executive Director issued a Summary Order regarding the license of Amy Bax, P.T.A. ("Licensee") to practice as a physical therapy assistant in the state of Kansas. The Summary Order suspended the license of Licensee until she remitted payment for \$75 renewal fee and the \$30 return check fee.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would be come effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. On May 13, 2011, Licensee paid the required \$75 renewal fee and the \$30 return check fee.

4. As Licensee paid the required fees prior to the effective date of the Summary Order the Summary Order did not become effective.

**IT IS THEREFORE ORDERED** that the Summary Order filed on May 3, 2011 is hereby dismissed.
