

4. The Consent Order provides that after one (1) year, Licensee may request modification of the provisions of the Consent Order and that he may request termination after two (2) years.

5. Licensee previously filed a motion seeking modification which was heard and denied by the Board in February of 2010. At the time, Licensee did not yet have a substantial record of compliance as many of the provisions had just been initiated.

6. Since entering into the Consent Order in December of 2009, Licensee has substantially complied with all provisions. Compliance documentation admitted as evidence in the conference hearing in this matter indicates Licensee's fulfillment of the Consent Order's terms to date.

7. On January 26, 2011, Licensee requested modification of the Consent Order such that his probation is lifted; confidential and his practice monitoring will continue in a non-disciplinary manner for one (1) year.

8. Disciplinary Panel #24 reviewed Licensee's request and authorized counsel for Petitioner to agree to the same.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS:


The probation placed upon Licensee's license is hereby **TERMINATED**.

IT IS FURTHER ORDERED that the practice monitoring requirement set forth in paragraph 24(j) through (o) shall continue in a non-disciplinary manner for one (1) year from the date this Order is filed. The practice monitoring requirement shall automatically terminate at the

end of one (1) year, unless Petitioner files a motion in opposition to termination prior to the end of the year.




