**FINAL ORDER GRANTING REQUEST FOR
TERMINATION OF MONITORING**

NOW on this 13th day of December 2013, comes before the Kansas State Board of Healing Arts (“Board”) the request of Alicia Bean, M.D. (“Licensee”) for termination of the monitoring requirement contained in the Consent Order filed on August 24, 2010. Licensee appears in person and with counsel, Mark Stafford. Jane Weiler, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of medicine and surgery in the State of Kansas, having been issued License No. 04-34611.
2. On or about August 24, 2010, Licensee entered into a Consent Order with the Board to resolve concerns regarding Licensee’s disclosure on her initial application to practice medicine and surgery in Kansas of discipline while in a training program; Confidential

3. The Consent Order required Licensee to comply with the following terms and conditions:

c. Practice under practice supervision for a minimum of six (6) month, which this requirement was terminated pursuant the October 27, 2011 Final Order Terminating Supervision Requirement.

5. On or about October 27, 2011, the Board issued a Final Order Terminating Supervision Requirement based upon Licensee's satisfaction of all terms and conditions for practice supervision in her Consent Order.

9. On November 12, 2013, Licensee submitted a request to the Board for termination of the Confidential monitoring requirement contained in the Consent Order.

10. On November 15, 2013, the Respondent Board filed a Response to Petition for Termination of Monitoring and offered documentary evidence of Licensee's compliance.


11. The Board finds that Licensee has satisfactorily met all terms of the Confidential monitoring requirement within the Consent Order and concludes that termination is warranted in the circumstances.

12. The ongoing therapy requirement in the Consent Order remains in effect.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Licensee's request for termination of Confidential monitoring imposed by the Consent Order filed on August 24, 2010, is hereby **GRANTED**.

IT IS FURTHER ORDERED that the Board shall maintain jurisdiction over this matter to issue any future order(s) deemed necessary and appropriate.

Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
