FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 14th day of February, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of Mark A. Beck, D.C. (hereafter "Licensee") for retroactive reinstatement of license.

Charlene Abbott, Licensing Administrator presented information before the Board. There were no other appearances.

After hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

1) Licensee failed to renew license number 1-03648 which was originally issued on July 1, 1983 and said license was subsequently cancelled August 1, 1997 pursuant to K.S.A. 65-2809 and amendments thereto.

2) Pursuant to Board records, Licensee applied for and received reinstatement of his license on August 25, 1997.

3) Licensee requested the Board retroactively reinstate his license to practice chiropractic in the state of Kansas from August 1, 1997 until the date of reinstatement, August 25, 1997.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That license number 1-03648 issued to Licensee which was cancelled on August 1, 1997 and reinstated on August 25, 1997, be retroactively reinstated to August 1, 1997 and that the records of the Board be amended to reflect that Licensee has continuously held a current license from and since August 1, 1997.

C. Licensee shall by March 25, 1998, provide evidence satisfactory to the Board that he has maintained a policy of professional liability insurance as required by K.S.A. 40-3402 for the time period of August 1, 1997 through August 25, 1997.


Should Licensee fail or be unable to provide evidence satisfactory to the Board of professional liability insurance by March 25, 1998, this Final Order shall be reconsidered by the Board at its next meeting on April 25, 1998.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


