FINAL ORDER

NOW ON THIS Twelfth Day of February, 2000, comes before the Board for a conference hearing Respondent's request to modify the order dated August 26, 1999 to allow him to practice the healing arts at the Moundridge Mercy Hospital. Respondent Randall R. Beech, M.D. appears through Stephen M. Joseph and in person. Stacy L. Cook, Litigation Counsel, appears for Petitioner.

Respondent's request was originally denied as stated in the order dated December 17, 1999, which followed the December 11, 1999 Board meeting. At that time, the Board found that Respondent had failed to comply with the previous Board orders requiring him to report all orders for controlled substances. The December 17 order gave notice that a hearing would follow to determine what, if any, discipline would be imposed for the failure to comply with the orders.

There is no apparent dispute that Respondent had failed to provide the Board with a record of all of his orders for controlled substances. The Board concludes that this is a violation of the healing arts act. There is also no dispute that, since service of the December 17, 1999 order, Respondent has supplied a record of his orders for controlled substances, and that he is not delinquent as of the date of the hearing.

Having brought himself into compliance with the prior orders, the Board determines that

further discipline is not necessary, and that his request to practice at Moundridge Mercy Hospital should be granted under the same limitations that apply to his practice at Kingman County Hospital.

IT IS, THEREFORE, ORDERED that Respondent's request to modify the limitation of his license to allow him to practice at Moundridge Mercy Hospital is granted, subject to the limitations stated in this order.

IT IS FURTHER ORDERED that Respondent may not engage in the practice of medicine and surgery at any location except within the Kingman County Hospital and the Moundridge Mercy Hospital.


IT IS FURTHER ORDERED that Respondent may not prescribe any controlled substance unless it is to be administered at the Kingman County Hospital or the Moundridge Mercy Hospital. Any controlled substance that Respondent orders as allowed by this final order must be reported to the Board in the same manner required by the June 15, 1998 Board order. If Respondent does not order a controlled substance within a reporting period, he must still make a report to the Board and indicate that no controlled substances were ordered.
