## FINAL ORDER

NOW ON THIS Twelfth Day of August, 2000 comes before the Board for a conference hearing Respondent's request to modify the order dated February 12, 2000 to allow him to practice the healing arts in the communities of Pratt and/or Lyons. Respondent, hereafter 'Licensee', Randall R. Beech, M.D. appears *pro se*. Stacy L. Cook, Litigation Counsel, appears for Petitioner.

After hearing statements from the parties and being duly advised in the premises, the Board finds as follows:

- On July 19, 2000, by letter Licensee requested the Board reconsider the limitation
  on his practice stemming from prior orders to include the additional communities
  of Pratt and/or Lyons, Kansas.
- 2. A Notice of Conference Hearing on this matter was mailed out on July 20, 2000.
- Licensee has been in compliance with the limitations and restrictions placed on him by the Board.
- Other limitations and restrictions placed on Licensee by prior orders shall remain in effect.

IT IS THEREFORE ORDERED that Licensee's request to modify the limitation of his license to allow him to practice in Pratt and/or Lyons, Kansas is granted, subject to limitations established by prior orders of the Board.

PLEASE TAKE NOTICE that this is a Final Order. A party may file a petition for judicial review in the district court. A petition for judicial review is not timely unless filed within 30 days following service of the Final Order.
