ORDER DENYING LICENSE

NOW, on this 15th day of August 1987, comes on for consideration the application for licensure to practice medicine and surgery in the State of Kansas by endorsement filed by the above-named applicant.

After considering the file and being otherwise duly advised in the premises, the Kansas State Board of Healing Arts, sitting in regular session and serving as presiding officer in accordance with K.S.A. 1986 Supp. 77-538 finds as follows:

1. That the application for endorsement filed by Jerome H. Begun, M.D. to practice medicine and surgery was received in the office of the Board on September 18, 1986.

2. That subsequent to the receipt of the application, applicant was advised that the application was considered to be incomplete **(Confidential)**

4. That applicant's application for licensure by endorsement to practice medicine and surgery in the State of Kansas should be denied for the following reasons:

A. That applicant has the inability to practice medicine and surgery in the State of Kansas with reasonable skill and safety to patients **(Confidential)**

B. That applicant has been convicted of a felony and has not provided to the Board sufficient evidence to reflect that he has been rehabilitated to warrant the public trust.

C. That the applicant has had his license to practice medicine and surgery revoked in the states of California, Indiana and Ohio.

D. That the states of Wisconsin, Maine, Michigan, Nevada and Virginia have heretofore denied applications submitted by applicant for licensure to practice medicine and surgery in those states.

E. That applicant made misrepresentations on the application for licensure by endorsement.

5. That the aforementioned reasons constitute sufficient grounds to

deny applicants application for licensure pursuant to K.S.A. 65-2805.

6. That this constitutes a final order of the Board .


7. That applicant may seek judicial review of this order pursuant to the Act for Judicial Review and Civil Enforcement of Agency Actions (K.S.A. 1986 Supp. 77-602 et seq.)

IT IS THEREFORE BY THE BOARD CONSIDERED, ORDERED AND DECREED that the application of Jerome H. Begun, M.D. for licensure by endorsement to practice medicine and surgery in the State of Kansas received in the Board office on September 18, 1986, should be and is hereby denied.
