ORDER OF DENIAL OF LICENSE

NOW on this 14th day of October, 1989, comes on for determination by summary proceedings the Application for Endorsement to obtain a license to practice medicine and surgery in the State of Kansas filed by Vishwas Govind Bhopale, M.D. (hereinafter "Applicant").

After considering the file and being otherwise duly advised in the premises, the Kansas State Board of Healing Arts (hereinafter "Board"), sitting at a regular meeting and serving as a presiding officer in summary proceedings pursuant to K.S.A. 1988 Supp. 77-511 and 77-537, as amended by L. 1989, Ch. 283, finds as follows:

1. That on the 18th day of September, 1989, Applicant filed with the Board an Application for Endorsement to obtain a license to practice medicine and surgery in the State of Kansas.
2. That K.A.R. 100-8-2 provides as follows:

"100-8-2. Applications. All Applications for Endorsement registration shall be upon forms furnished by the Kansas Healing Arts Board and these forms shall contain the following in plain, common legible writing:

*** (e) Certified statement in detail of professional education showing healing arts schools or colleges attended, periods of study, degrees obtained and date of graduation."

3. That the Application filed by Applicant on September 18, 1989, did not have part X entitled, "Certificate of Professional College" completed.

4. That by letters dated September 4 and September 13, 1989, Applicant advised the Board of the difficulties he has in completing the aforementioned portion of the Application and the reasons such portion thereof was not completed.

5. That by letter dated September 26, 1989, Applicant was notified of the requirement that section X be completed and of his omission in completing said portion and further advised of the necessity to complete said portion before the Application could be deemed to be complete.

6. That as a result of Applicant's failure to provide the Certificate of Professional College as required on the Application for Endorsement and K.A.R. 100-8-2, said Application does not comply with the rules and regulations of the Board.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

a. That Applicant's Application for Endorsement received in the Board office September 18, 1989 should be denied.


b. That Applicant, pursuant to K.S.A. 1988 Supp. 77-511 and 77-537, as amended, is entitled to request a hearing before the Board or a presiding officer appointed by the Board on his Application for Endorsement.

c. That a request by Applicant for a hearing must be made in writing to the Kansas State Board of Healing Arts, 900 S.W. Jackson, Suite 553, Topeka, Kansas 66612, within fifteen (15) days after service of this Order on Applicant.

d. That this Order will become effective if a hearing is not requested as above stated upon the expiration of the time for requesting such a hearing.




