ORDER OF RETROACTIVE MODIFICATION TO LICENSE STATUS

NOW, on this 10th day of December, 1993, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a summary proceeding pursuant to the provisions of K.S.A. 77-537, the request to retroactively modify the license status of Peter V. Bieri, M.D. (hereafter "Licensee").

Charlene K. Abbott, Licensing Administrator, appears on behalf of the Board. Licensee did not appear. There are no other appearances.

After reviewing the request and being otherwise duly advised in the premises, the following findings are made:

1. Licensee was originally licensed to practice medicine and surgery in the State of Kansas on July 1, 1992, which license was reinstated as exempt at request of Licensee on June 14, 1993.

2. On October 21, 1993, Licensee met the requirements to have his license changed from exempt to active and said status was so changed effective said date.

3. That as of September 1, 1993, Licensee had met the necessary requirements to qualify for an active license.

4. That by inadvertence, Licensee failed to make proper application to change his license status from exempt to active in a timely fashion.

IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:

A. That the findings here and above made be the same are made the order of the Board.

B. The status of the license of the Licensee, Peter V. Bieri, M.D. to practice medicine and surgery in the State of Kansas should be retroactively modified to reflect that Licensee's license was placed on active status as of September 1, 1993 and such active status has continued from and since said date.

C. This is a Summary Order. Any party may within seven (7) days after service, request a hearing on the Order. If a hearing is not requested, the Order shall become effective upon the expiration of the time for requesting a hearing.
