FINAL ORDER REVOKING LICENSURE AND ASSESSING COSTS

NOW on this 2nd day of December 2011, comes before the Kansas State Board of Healing Arts (“Board”) the matter of Frank H. Boehm, M.D. (“Licensee”) for review of the Initial Order of the Presiding Officer filed on September 27, 2011. Licensee does not appear. Stacy Bond, Associate Litigation Counsel, appears on behalf of the Board.

Pursuant to the authority granted to the Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of Ms. Bond, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Frank H. Boehm, M.D. (“Licensee”), is licensed to engage in the practice of medicine and surgery in the State of Kansas, License No. 04-34394, and has been so licensed since approximately May 21, 2010.


2. The Board accepts, adopts and incorporates herein by reference the Statement of the Case, Findings of Fact, Conclusions of Law, Conclusions and Orders contained in the INITIAL ORDER in this FINAL ORDER.

3. The Board further finds that upon consideration of all relevant circumstances in this proceeding, the costs of the proceeding in the amount of \$565.50 as set forth in Petitioner’s Statement of Costs should be assessed to Licensee pursuant to K.S.A. 65-2846


IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Licensee's license, No. 04-34394, to practice medicine and surgery in the State of Kansas is hereby REVOKED.

IT IS FURTHER ORDERED that Licensee shall pay the Board's incurred COSTS in conducting these proceedings under the Kansas Administrative Procedure Act in the amount of \$565.50, which shall become due and owing on January 30, 2012. Licensee shall make payment of the COSTS payable to the "Kansas State Board of Healing Arts" and send such payment to: Compliance Coordinator, Kansas State Board of Healing Arts, 800 SW Jackson, Lower Level-Suite A, Topeka, Kansas 66612.

Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
