1. Todd Jason Bohnen, O.T.A. (“Licensee”) has, since approximately November 6, 1998, maintained License No. 18-00391 to engage in the practice as an occupational therapist in the State of Kansas.

3. On or about April 20, 2011, Licensee entered into a Consent Order (Consent Order) with the Board for alleged violations of the Occupational Therapy Practice Act. Under the terms of the Consent Order License was required to pay a fine of \$250.00, to be remitted to the Board, in full, on or before September 1, 2011.


4. On or about September 14, 2011, Licensee satisfied the provision of the Consent Order requiring payment of a fine in the amount of \$250.00.

5. Licensee has satisfactorily met all requirements of the Consent Order and has no


further obligation for compliance.


