AGREED ORDER OF DISMISSAL WITHOUT PREJUDICE

NOW on this the 23 day of June, 2009, comes before the Kansas State Board of Healing Arts ("Board") the agreement of the parties to dismiss the presently pending First Amended Petition without prejudice. Petitioner appears by and through Lori D. Dougherty, Associate Litigation Counsel ("Petitioner"), and Michael S. Bolt, M.D. ("Licensee") appears by and through counsel Randall J. Forbes, of Frieden & Forbes, P.A.

The parties agree and stipulate to the following:

1. Licensee was issued License No. 04-21978 on December 12, 1987, and last renewed such license on July 28, 2006.
2. On or about April 15, 2007, Licensee ceased actively practicing medicine.
3. On July 26, 2007, Petitioner filed a Petition in this matter, and a First Amended Petition was filed on November 14, 2007.
4. On or about August 1, 2007, Licensee's license was canceled by operation of law for failure to renew.
5. Should Licensee apply for reinstatement of licensure in the future, the allegations and issues raised in the First Amended Petition may be considered by the Board at that time.

IT IS THEREFORE ORDERED that the First Amended Petition is hereby dismissed without prejudice.


