**JOURNAL ENTRY SUSTAINING UNOPPOSED MOTION TO STAY
PROCEEDINGS**

On October 29, 2019, the Kansas State Board of Healing Arts through the presiding officer, Dr. Robin Durrett, D.O., and the agent of the presiding officer authorized by K.S.A. 77-551(c), enters this journal entry memorializing the Board’s order on the Motion for Stay Emergency Suspension and Hearing filed by Dr. Bond. Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.*, the Kansas and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, and after reviewing the agency record, hearing the arguments of the parties, and being duly advised in the premises, the Board makes the following findings, conclusions, and orders:

The motion is unopposed. Dr. Bond is not currently practicing and has changed his license status to inactive. Due to Respondent’s current inactive license status, staying this matter does not pose a risk to the health and safety of the public. Therefore, the presiding officer advised the parties on October 18, 2019 that the motion was granted, the matter stayed, and the Emergency Order temporarily suspending Dr. Bond’s license terminated.

The Emergency Order temporarily suspending Dr. Bond’s license is terminated without prejudice and this matter is **STAYED** until such time as either party files a motion to lift the stay, Dr. Bond seeks to change his license status to active, or until such time as the presiding officer deems it necessary for this matter to proceed.


