SUMMARY ORDER DENYING APPLICATION FOR REGISTRATION

NOW, on this 21st day of February, 2003, this matter comes before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board") in summary proceedings pursuant to K.S.A 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and orders are made for and on behalf of the Board:

1. The application of Gauri Dilip Borse (hereafter "Applicant") for registration to practice physical therapy in the state of Kansas was received in the Board office on February 4, 2003.

2 On or about February 12, 2003, the Board received a Summary of Evaluation of Educational Credentials from International Consultants of Delaware, Inc. that indicates "For the purpose of licensure in the state of Kansas, it should be noted that the applicant <u>does not</u> meet the physical therapy licensure requirements as set forth by the Kansas Board of Healing Arts."

3. On or about February 12, 2003, The Board Physical Therapy Examining Committee met to review the application of Applicant. The Committee recommended that the application be denied as Applicant had not met the educational requirements for registration as a physical therapist.

4. Pursuant to K.S.A. 65-2906(b)(2) applicant has not successfully completed the academic requirements of an educational program in physical therapy approved by the board.

IT IS THEREFORE ORDERED that the application of Applicant to practice physical therapy in the state of Kansas is denied due to failure to meet the educational requirements as provided by K.S.A. 65-2906(b)(2).

This is a Summary Order and either party is entitled to a review if a written request is received in the Board office within 15 days of service of the Summary Order upon the parties. If no request is received, this Order will become immediately effective.
