JOURNAL ENTRY ON APPROVAL OF CONSENT ORDER WITH AMENDMENT

On December 13, 2019, the parties appeared before the Kansas State Board of Healing Arts (“Board”) for a conference hearing on the approval of the Consent Order in the above captioned matter. Joseph Bosiljevac, M.D. (“Licensee”) appeared in person, and through counsel, Kelli Stevens of Forbes Law Group, LLC. Matthew Gaus, Associate Litigation Counsel, appeared on behalf of the Board.

The parties submitted a proposed Consent Order for the Board’s review and approval. Upon review of the proposed Consent Order, and taking into consideration the statements and testimony received at the hearing, the Board approved the Consent Order with the following amendment, as agreed by all parties:

1. Licensee is hereby ordered to pay a **FINE** in the amount of **TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00)** for violations of the Kansas Healing Arts Act.


All other provisions of the Consent Order remain unaltered.


