**JOURNAL ENTRY OF SATISFACTION
OF REQUIREMENTS OF FINAL ORDER**

NOW, on this 23rd day of February 2010, this matter comes before Kathleen Selzler Lippert, Interim Executive Director, Kansas State Board of Healing Arts (“Board”), concerning Licensee’s satisfaction of all requirements contained in the Final Order which was filed on January 21, 2010. Wherefore, the Board finds as follows:

1. On or about January 20, 2010, the Board issued a Final Order regarding the license of Maged S Botros, M.D. (“Licensee”) to practice medicine and surgery in the state of Kansas. The Final Order contained a provision for Licensee to pay a fine in the amount of \$500 within thirty (30) days of the effective date of the Summary Order. The Summary Order became effective January 7, 2010.

2. Licensee paid the \$500 fine on February 16, 2010.

3. On or about January 20, 2010, the Board issued a Final Order regarding the license of Maged S Botros, M.D. (“Licensee”) to practice medicine and surgery in the state of Kansas. The Final Order contained a provision for the Licensee to submit proof of 50 hours of continuing education, due within fifteen (15) days of the effective date of the Summary Order. The Summary Order became effective January 7, 2010.

4. Licensee submitted 50 hours of continuing education on February 15, 2010.

5. Licensee has satisfied all requirements of the Final Order and has no further obligation for compliance.

ITS IS THEREFORE ORDERED that Licensee is hereby discharged from the requirements of the Final Order filed on January 21, 2010.


