JOURNAL ENTRY LIFTING SUSPENSION

The Kansas State Board of Healing Arts ("Board"), by its Executive Director, Tucker L. Poling, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On April 13, 2021, a Final Order was issued by the Board against the license of Blythe E. Bowman, M.D. ("Licensee"), imposing requirements therein and suspending her license until such time as she came into compliance with Kansas Health Care Stabilization Fund ("KHCSF"),
2. On or about June 30, 2021, Licensee submitted to the Board proof she had paid the surcharges required by K.S.A. 40-3404, bring her into compliance.
3. On or about July 1, 2021, Associate Litigation Counsel filed a Motion to Modify Final Order and/or Lift Suspension.


Therefore, the Motion to Modify Final Order and/or Lift Suspension is **GRANTED**, and the suspension of Licensee's license to practice medicine and surgery in Kansas is

LIFTED.


