1. On February 9, 2009 the Executive Director issued a Summary Order regarding the license of Constance K Bradbury, LRT ("Licensee") to practice as a Radiologic Technologist in the state of Kansas. 

## SUMMARY ORDER

**NOW ON THIS** day of February, 2009, this matter comes before Jack Confer, Executive Director, Kansas State Board of Healing Arts ("Board"), in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, the following findings of fact, conclusions of law and order are made for and on behalf of the Board:

1. Constance Bradbury, LRT ("Licensee") was originally issued license number 22-

00499 to practice as a Radiologic Technologist in the State of Kansas on September 13, 2005.

2. On or about August 17, 2008, Licensee submitted an application for renewal of their license.

3. Pursuant to K.S.A. 65-7307 and K.A.R. 100-73-7 each Licensee desiring to renew a Radiologic Technologist license must have completed at least 12 credits of continuing education and to provide proof of completion to the Board upon request

4. As part of the renewal process, Licensee certified that the rules regarding continuing education had been read, that compliance had been achieved, and that documentation of the continuing education would be maintained for a three-year period and produced to the Board upon request.

5. Licensee was randomly selected to provide verification of compliance with the continuing requirements and on November 14, 2008, a letter was mailed to Licensee requesting that Licensee provide no later than December 31, 2008, the records relied upon when Licensee certified achievement of the required continuing education.

6. Licensee has failed to provide documented evidence of continuing education by the due date.

7. By failing to provide documented evidence of continuing education, Licensee has violated K.S.A. 65-7307(c), failing to provide evidence of satisfactory completion of 12 hours of continuing education.

8. In addition to any other penalty prescribed under the Radiologic Technologist Practice Act, K.S.A. 65-7313 and K.S.A. 65-2836a authorizes the Board to assess an administrative fine in an amount not exceeding \$5,000 for the first violation of the Radiologic Technologist Practice Act.

**IT IS, THEREFORE, ORDERED** Licensee is hereby fined \$250 for failure to respond to the Board's legal request for information. The fine is due within thirty days of the effective date of this order.

IT IS FURTHER ORDERED that licensee shall submit proof of the continuing education requirements for the previous year to the Board with fifteen days following service of this summary order.

**PLEASE TAKE NOTICE** that this is a summary order. A party to whom a summary order is issued may file a written request for a hearing within 15 days following service of the summary order. If a hearing is not requested, the summary order shall become effective as a final order of the Board upon expiration of the time for requesting a hearing. A request for a
