PROPOSED DEFAULT ORDER

NOW ON THIS Twelfth Day of February 2005, this matter comes on for hearing upon the application of Earl Dean Bray, M.D. for reinstatement of his license. Applicant does not appear. Kelli J. Benintendi, Associate Counsel, appears for the Board.

The Board finds that Applicant is in default. The allegations of fact appearing in the Response in Opposition to Application for Reinstatement are deemed to be undisputed. Having the agency record before it, the Board proposes to find, conclude and order as follows:

- Applicant received a license to practice medicine and surgery in the State of Kansas on July 1, 1961. That license was cancelled August 1, 2000 based upon Applicant's failure to renew.
- 2. The State of Ohio indefinitely suspended Applicant's license in that state based upon Applicant's failure to complete the required continuing education hours.
- 3. Applicant stated on his application for reinstatement that no licensing agency had limited, restricted, suspended or revoked a license that he had held.
- 4. Applicant has not actively practiced medicine and surgery since June 2001.

5. The Board concludes that as provided by K.S.A. 65-2836(a), (b) and (j),

there are grounds to deny the application for reinstatement.

IT IS, THEREFORE, ORDERED that the application for reinstatement by Earl

Dean Bray, M.D. is hereby denied.

PLEASE TAKE NOTICE that this is proposed default order. A party may file

a motion to vacate a proposed default order within seven days following service of the

proposed order. Any such motion must be filed with the Executive Director at 235 S.

Topeka Blvd., Topeka, KS 66603. A proposed default order becomes effective as a final

agency order after the expiration of the time within which the party may file a written

motion to vacate the proposed default order.
