ORDER DENYING THIRD TEMPORARY REGISTRATION

NOW on this 8th day of December, 1995, this matter comes on for summary proceedings at the request of Vicki Breeze (hereafter "Registrant") to grant a third temporary registration pursuant to K.S.A. 65-5508(e).

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereafter "Board").

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. Registrant's request for a third temporary registration was received by the Board on December 1, 1995, and summary hearing was set for December 8, 1995 at 1:30 p.m.
2. Registrant has applied for permanent registration as a respiratory therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5506(a)(3).
3. Registrant was issued temporary registration number 9401814 on February 25, 1994, which expired February 25, 1995. Registrant was subsequently issued second temporary registration number 9502295 on June 23, 1995, which expired on October 30, 1995.

ORDER DENYING THIRD TEMPORARY PERMIT

4. Pursuant to K.S.A. 65-5508(e), not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

5. The Board finds that insufficient cause exists to grant Registrant a third temporary registration. Registrant may reapply for registration once she has passed the required exam, has provided proof as such, and has met all of the requirements for permanent registration as a respiratory therapist.

IT IS THEREFORE ORDERED as follows:

- a. That Registrant's request for a third temporary registration is denied.
- b. That any party may, within fifteen (15) days of service of this Order, file a Petition for Reconsideration or submit a written request for hearing. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review. If a hearing is not requested within fifteen days after service, this shall become effective as a final order of the Board.

IT IS SO ORDERED.


