ORDER RESCINDING STIPULATION AND ADDENDUM THERETO

NOW, on this 28th day of October, 1988, comes on for hearing the request of Richard L. Brownrigg, M.D., hereinafter referred to as "Licensee", for a rescission of stipulation and addendum to stipulation.

After reviewing the file, hearing the statements of Licensee and being otherwise duly advised in the premises, the Kansas State Board of Healing Arts finds as follows:

1. That on or about August 29, 1986, Licensee entered into a stipulation in which Licensee surrendered and resigned his license to practice medicine and surgery in the State of Kansas.

2. That Licensee has heretofore applied for reinstatement of his license to practice medicine and surgery in the State of Kansas.

3. That on or about July 8, 1988, the Board and Licensee entered into an Addendum to Stipulation which declared paragraph 1 of the Stipulation dated August 29, 1986 null and void and of no further force and effect and reinstated the license of Licensee on certain terms and conditions.

4. That from and since the addendum to stipulation, Licensee has complied with all of the requirements of the addendum as well as the requirements set forth in the Stipulation dated August 29, 1986.

5. That the Stipulation between the parties dated August 29, 1986 and the Addendum to Stipulation dated July 8, 1988 should be rescinded in their entirety and hereafter declared null and void.


6. That with the rescission of the Stipulation and the Addendum to Stipulation, the license to practice medicine and surgery issued to Licensee shall be without any limitations or restrictions.

IT IS THEREFORE ORDERED BY THE BOARD, sitting in regular session, that the Stipulation dated August 29, 1986 and the Addendum to Stipulation dated July 8, 1988 between Licensee and Board both be rescinded in their entirety and shall hereafter be null and void and of no further force and effect and that the license of Licensee to practice medicine and surgery in the State of Kansas shall hereafter be without any restrictions or limitations.

IT IS SO ORDERED.



ADDENDUM TO STIPULATION

THIS ADDENDUM made and entered into this 8th day of July, 1988, by and between the KANSAS STATE BOARD OF HEALING ARTS, hereinafter referred to as "Board" and RICHARD L. BROWNRIGG, hereinafter referred to as "Licensee".

WITNESSETH:

WHEREAS, the parties previously entered into a Stipulation dated August 29, 1986 in which Licensee surrendered and resigned his license to practice medicine and surgery in the State of Kansas; and

WHEREAS, Licensee is currently on a work release program and has obtained employment at the Wesley Medical Center in Wichita, Kansas; and

WHEREAS, pursuant to paragraph 2 of the aforementioned stipulation, Licensee is desirous of having his license reinstated on a limited basis at this time.

NOW, THEREFORE, in consideration of the promises and covenants contained herein as well as the aforementioned stipulation, the parties hereto further agree as follows:

1. That paragraph 1 of the aforementioned stipulation is hereby null and void and Licensee, upon submission of the appropriate application for reinstatement together with required supporting documents, shall have his license to practice medicine and surgery in the State of Kansas, said license being number 13834, reinstated on the following terms and conditions:

A. Licensee may engage in the practice of medicine and surgery under the license hereby reinstated only in his capacity as an employee of Wesley Medical Center, Wichita, Kansas, and shall not otherwise engage in the practice of medicine and surgery.


B. While an employee of Wesley Medical Center, Wichita, Kansas, Licensee shall engage in the practice of medicine and surgery under the license hereby reinstated only under the supervision and direction of an individual who has an unrestricted license to practice medicine and surgery in the State of Kansas.

2. Except as hereinabove amended or modified, the Stipulation between the parties dated August 29, 1986 shall remain in full force and effect and shall not be rescinded or amended by the execution of this addendum, it being particularly understood and agreed that the provisions of paragraph 3 of said Stipulation must be fulfilled by Licensee prior to the Board giving con-


sideration to any application by Licensee for a full and unrestricted license to practice medicine and surgery in this state.

IN WITNESS WHEREOF, the parties hereto have executed this Addendum on the date indicated below their signature, it being specifically understood that the effective date of this Addendum will be the date on which Licensee has submitted a completed application for reinstatement, paid the appropriate fee and provided to the Board such other information as it may deem appropriate.
