FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT

NOW on this 9th day of October 2015, comes before the Kansas State Board of Healing Arts ("Board") the application of Anthony Burgess, MD ("Applicant") for a license by endorsement to practice medicine and surgery in the State of Kansas. Applicant appears in person and *pro se*. Reese Hays, Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the application, hearing the testimony of Applicant, and otherwise being duly advised in the premises, the Board makes the following findings, conclusions and order:

1. On or about August 31, 2015, Applicant submitted an application to the Board for a license to practice medicine and surgery in the State of Kansas. Such application was complete and filed with the Board on September 14, 2015.
2. Applicant requests that he be granted licensure by endorsement pursuant to K.S.A. 65-2833, based on his active medical licenses in Minnesota and Missouri granted in 2013 and 2014, respectively. Both licenses are currently active with no disciplinary actions.

3. Applicant began his medical school education at St. Matthews School of Medicine in Grand Cayman in 2004, and graduated in 2008. The Board disapproved St. Matthews in 2006, while Applicant was still in attendance.

4. In June of 2010, Applicant completed his PGY-1 transitional year of postgraduate training at Mercy Health Care Center in Toledo, Ohio. He then completed a three-year residency in Physical Medicine and Rehabilitation at Marianjoy Rehabilitation Hospital in Wheaton, Illinois in June of 2013. Both programs were accredited by Accreditation Council for Graduate Medical Education (“ACGME”).

5. Between 2006 and 2010, Applicant passed all steps of the United States Medical Licensing Examination (“USMLE”) on his first attempt of each step.


6. Since May 2014, Applicant has actively practiced medicine at Integrated Rehab Consultants in Independence, Missouri.

7. Applicant is board-certified in Physical Medicine and Rehabilitation by the American Board of Physical Medicine and Rehabilitation.

8. The Board finds that the Applicant has demonstrated satisfactory fulfillment of the requirements of K.S.A. 65-2833 to be granted a license by endorsement to practice medicine in the State of Kansas.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby GRANTED a license by endorsement to practice medicine and surgery in the State of Kansas.


