ORDER DENYING THIRD TEMPORARY REGISTRATION

NOW on this 19th day of October, 1996, this matter comes on for conference proceedings at the request of Musalia Busaka (hereafter "Applicant") to grant a third temporary registration pursuant to K.S.A. 65-5408(d).

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereafter "Board"). Applicant does not appear. Sandra Ward, President of the Occupational Therapist Council appears.

After hearing statements from the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

- 1) A request for a third temporary registration was submitted by Applicant, and conference hearing was set for October 19, 1996.
- 2) Applicant has applied for permanent registration as a occupational therapist, but has not passed an exam approved by the Board as required by K.S.A. 65-5406(a)(3).
- 3) Pursuant to K.S.A. 65-5408(d), not more than one temporary registration shall be permitted to any one person without the majority approval of the members of the Board.
- 4) The Board finds that insufficient cause exists to grant Applicant a third temporary registration. Applicant may reapply for a third temporary registration on cethe required exam has been

passed and proof has been provided as such, and all of the requirements for permanent registration as an occupational therapist have been met.

IT IS THEREFORE ORDERED as follows:

- a. That Applicant's request for a third temporary registration is denied.
- b. That this is a final order and is effective upon service upon the parties. Any party may, within fifteen (15) days of service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
